## What work does Rogers Dance Academy carry out with young children?

**KR:** The academy delivers an extensive education programme for all ages and abilities, offering a range of dance activities right across the country. We provide multicultural workshops in early years and primary settings which are curriculum-linked, raising attainment and achievement and helping to get young people active.

#### Why did you decide to take safeguarding training with Child Protection Training UK?

KR: We work with children, as well as vulnerable people; safeguarding training in this area is mandatory and everyone's responsibility. We chose Child Protection Training UK in particular because of recommendations made by the schools and nursery managers we've worked with. We also found that their website offered a wealth of advice, including up-to-date information on current legislation.

#### What training have you taken, and what did it involve?

**KR:** All of our staff and freelance teachers have undertaken the Level 1, 2 and 3 training, in line with government legislation. Child Protection Training UK were fantastic as they were able to offer us a variety of training seminars to suit our needs - from on-site training days, to twilight and weekend sessions, which ensured all our staff were equipped with the knowledge necessary to spot signs of abuse and follow the correct reporting procedures. All the courses we've undertaken were a day long, except for the twilights which took place over two sessions.

From day one we were given guidance and support on policy implementation, and were offered advice and training on safeguarding issues exceeding Ofsted's requirements. We've found their hands on approach particularly useful – safeguarding is a sensitive topic, but having practical

examples delivered in a down-to-earth manner is something that we've all appreciated.

## How useful have you found the training?

#### Are you intending to complete any further training in this area?

**KR:** Safeguarding training is an ongoing process – to ensure that we meet Ofsted requirements, all staff receive updated training regularly – and we fully intend to work closely with Child Protection Training UK moving forward, as they offer excellent value for money. We will also be undertaking further training around the Vetting and Barring scheme with them as part of our continuing safeguarding commitment.
